# **Bluebird - South Junction Exploration Update**

### Resource definition programme continues to extend mineralisation

**Westgold Resources Limited (ASX: WGX, OTCQX: WGXRF – Westgold or the Company)** is pleased to provide an update in relation to the ongoing exploration and resource development program at the Bluebird – South Junction Project at the Company's Murchison Operation.

## Highlights

- Recent significant South Junction drill intercepts include:

### Westgold Managing Director and CEO Wayne Bramwell commented:

"Westgold's corporate strategy is to expand the scale, productivity and profitability of our biggest mines. The Bluebird-South Junction open pits have previously delivered more than 1Moz of gold production and the current drilling under these pits has not yet defined the limits of the deeper mineralisation in any direction.

The full resource conversion programme continues and the assays returned thus far continue to build confidence around the next phase of underground expansion of this mine. Developing the South Junction side of the Bluebird-South Junction system will open a new mining front and in conjunction with the Bluebird underground ore, will underpin production from our Meekatharra operations for many years."

## **South Junction Resource Definition Exploration Program**

Westgold has invested in a major extensional exploration / resource definition drilling project at Meekatharra under the historic South Junction and Bluebird open pits. The company is currently mining the Bluebird lodes. Drilling is underway with three surface drill rigs and an additional underground drill rig to explore the down-plunge extents of these orebodies which historically produced +1Moz from open pits.

While Westgold has, and continues to explore beneath Bluebird, the current drill program is focussed on South Junction which has seen little exploration since open pit mining ended in 2013.

Westgold recently released an updated Mineral Resource Estimate (**MRE**) for Bluebird - South Junction of **6.4Mt @ 3.1g/t Au for 827Koz Au** representing an outstanding 134% increase<sup>1</sup>. This updated MRE, only included a single South Junction hole drilled during 2024 (**10.45m at 3.80g/t Au** from 788m and 3.98m at 10.80g/t Au from 894.49m in 24SJDD001), with subsequent drilling continuing to return exciting results.

South Junction hosts numerous mineralised zones broadly located on sub-parallel northnortheast-trending structures. These zones from west to east are, Edin Hope, South Junction, Polar Star and Archenar. These zones are offset from the East, Central and Western lodes at Bluebird, with the interaction between the two poorly understood due to a lack of drilling.

The current drilling program aims to investigate mineralisation in the link zone between Bluebird and South Junction and explore the down-plunge (grid south) potential. An expansion of this mine could see ore production from the Bluebird mine increase from the current rate of ~500ktpa via its existing two declines through the addition of a new decline into South Junction.

Greater volumes of ore from the Bluebird-South Junction mine, situated adjacent to the Bluebird mill, reduces reliance on lower grade feed hauled from Cue and will increase feed grade to the Bluebird mill and reduce overall production costs.

To date, a total of 18 drill holes for 16,400 metres have been completed from a planned program of some 26,000m of drilling. Assay results have now been received for 9 holes with the remainder pending (**Figure 1**).

Recent assay results continue to impress with drill holes focussed on providing sufficient data to upgrade the current Inferred component of the new MRE to Measured and Indicated. In addition, holes targeting the interpreted extensional areas down plunge to the south have also been drilled. Full details are provided in **Appendix A**.

The approved South Junction drill program is around 60% complete. With assays currently only returned for half the holes drilled to date Westgold looks forward to providing the market with further updates as the South Junction exploration program continues.

## **Murchison Operations – Background Overview**

Westgold's Murchison Operations incorporates four (4) underground mines, two (2) processing plants and one (1) development project, bookended by Cue in the south and Meekatharra in the north. Westgold's Bluebird processing hub is at the northern end of this package and located approximately 15km southwest of Meekatharra (**Figure 2**).

The Bluebird underground mine is the primary ore source feeding the 1.4-1.8Mtpa Bluebird processing plant. Surface stockpiles and supplementary ore from Cue is trucked to Bluebird to maintain processing throughputs.



## **Looking Forward**

Westgold's corporate strategy is to make our biggest mines bigger, more productive and hence deliver increased free cash flow. The expansion of the Bluebird-South Junction mine to include new mining fronts in South Junction is consistent with this plan.

The execution of the South Junction expansion requires an optimised mine design. The South Junction drilling programme, which is focused on Mineral Resource to Ore Reserve conversion and extension of overall mineralised inventory is already delivering mine life confidence though the success it has achieved to date. In parallel Westgold is conducting studies to understand the likely scale of production, potential mining methods and positioning of infrastructure to optimise South Junction extraction.

Excitingly, the orebody is also open to the North. Westgold is currently developing an underground diamond drill platform which aims to test the Bluebird North portion of the broader system. If successful, Bluebird North could present another option to expand mine production rates.

Westgold looks forward to providing updates as to our progress at Bluebird – South Junction over the coming months.
