### Full Year Financial Results & Bonus Option

Westgold Resources Limited (**Westgold** or the **Company**) is pleased to release its 2017 financial results. Westgold was listed on the Australian Securities Exchange (**ASX**) on 6 December 2016 following its demerger from Metals X Limited.

For full information, refer to the Financial Report for the Year Ended 30 June 2017 released today.

### **Key Results**

- Revenue up 43.5% over previous year to \$437.14 million.
- Cash flow from operating activities increased 52% over previous year to \$75.59 million.
- Gross profit increased 1,508% to \$31.46 million.
- Net profit before tax increased by 185% to \$24.62 million.
- Net profit after tax increased 177% to \$15.77 million.
- Net assets increased 188% to \$299.64 million.
- Cash and cash equivalents at year end of \$67.14 million.

### Capital reinvested in growth during the year

- Investment in 'Property Plant & Equipment' of \$35.3 million.
- 'Mine Properties & Development' expenditure of \$63.8 million.
- 'Exploration and Evaluation' expenditure of \$23.9 million.

### **Bonus Option**

The Board declares that no dividend is payable for the full financial year.

However, given the success of the Company during the year and with reference to it only reflecting seven months of operating history, the Board has elected to reward its loyal and supportive shareholders with a pro rata one for five bonus option. The principal terms and conditions of the new options are as follows:

- Class of security to be issued options over ordinary shares in the Company.
- Number of securities to be issued approximately 64,162,204 options (subject to rounding).
- Issue price of bonus options nil consideration.
- Record Date to determine entitlement 5pm (WST) on 14 September 2017.
- Exercise price of options \$2.00.
- Expiry date of options 5pm (WST) on 30 June 2019.
- Options to be issued to eligible shareholders resident in Australia, New Zealand and Hong Kong.

The Company will apply to have the option class listed on the ASX.

Anyone who wishes to acquire the new options simply needs to be an eligible registered shareholder in the Company on the Record Date. No application form will need to be completed.

A prospectus for the new options will be lodged with ASIC and announced on the ASX on or about 8 September 2017. It is expected to be mailed to shareholders on or about 20 September 2017, with the new options to be issued on or about 28 September 2017.

Further details of the new options will be provided in the prospectus.

### **Managing Director's Comment**

"This is a great inaugural result. Westgold has had a successful seven months trading as a separate publicly listed gold company.

The growth in our revenue, cash flow and profits represents a maturing company whilst the capital re-investment in the groups new and expanding asset base and future growth. Our existing operations continue to deliver positive outcomes whilst our key Central Murchison Gold Project continues to rampup and expand.

Additionally, the completion of refurbishment and the declaration of commercial production of the Fortnum Gold Project at year-end continued our growth in gold output.

It is only fitting that we reward our loyal and supportive shareholders with a bonus option in lieu of a dividend following our inaugural financial report representing nearly seven months since the Company began trading again on the ASX."
